A. Public Comment There was no public comment.

## B. SRAVTE Update:

- a. Dr. Stecken presented an updated rewrite of the SRAVTE agreement authored by Mr. Dwayne Mentgen. This rewrite was due to a mandate from ISBE. Without an update, grant funding to the member schools and SRAVTE and ACC will be frozen. Each member school's Board of Education would need to approve the new agreement. The necessary language in Section 256 includes a list of members of the Board of Control, clearly articulated roles, and responsibilities for all entities in the cooperative, implementation, and oversight of CTE programming, assessment and evaluation of the system, as well as a comprehensive plan and oversight of Perkins V and fiscal responsibilities. This rewrite meets the state of Illinois mandate, as required by the Perkins V legislation. It is Dr. Stecken's recommendation to approve the cooperative agreement as presented at the Policy Committee.
